Sports Club Security Services:

A Sports Club Security Services is a person employed by the government or private party to protect the employing party's assets from the variety of hazards (such as waste, damaged property, unsafe worker behavior, criminal activity such as theft, etc.) This is usually done for extra income, and work is particularly done in hazardous jobs such as body guard work and bouncer outside night club.

General Security Guard Services:

A General Security Guard work for security agency that gets hired by third parties to protect and guard their assets (e.g. property, people, equipment, or money) They can be armed or unarmed and used specialized equipment or tactics to do their job. Security Guard used various types of equipment to do their job (e.g video cameras, motion sensors, alarms, and lethal or non-lethal weapons, always compliance with regulations.) The level of security required and the means to protect an asset will depend on the clients profile and what they are intending to protect.

Event Security and Body Guards Services:

A Event or Body Guard (or close protection officer) is a type of security guard, or government law enforcement officer, or soldier who protect a person or a group of people – usually high ranking public officials or officer, wealthy people, and celebrities from danger: generally theft, assault, kidnapping assassination, harassment, loss of confidential information, threats, or other criminal offences. The personnel team that protects a VIP is often referred to as the VIP's security detail.
